7 Other Business

7.1 **Grants.** As previously discussed, it was confirmed thata grant of £297.99 be awarded to ECT to support the proposed Sharing Shed – payment to THC as the Third Party Contribution of the approve Landfill Tax award.

Noted that ESEG had been unable to secure funding via the Landfill Tax route due to the short length of lease they held over the Pavilion. Following discussion and a proposal, by JMcH seconded by SD, it was agreed to award a grant of £7,082.15.

7.2 **Bus Times**. CP raised a concern that the existing timetable did not suit those employed in Schools and other workplaces with similar work patterns. Agreed to raise with Stagecoach.
