### Road Safety and Road Crime

Intention - With Partners, enhance Road Safety across the Highland Area.

Objective – With Partners, deliver a Road Safety Strategy focusing on: Challenging driver behaviour; Education at the roadside and elsewhere; Detection of offences linked to contributing factors of Fatal and Serious Road Traffic Collisions and collectively reducing potential harm.

During June, three speeding offences have been detected, with the highest speed recorded being 83mph on B817 at Ballachraggan.

Two motorists have been charged with Dangerous Driving in Alness and Invergordon respectively. There have been thirteen miscellaneous road traffic offences recorded and detected, including vehicles being used without a valid MOT or insurance or vehicles being driven without a substantive driving license.

A motorist was also arrested for drink driving at Skiach Services.

### Anti-Social Behaviour, Disorder and Violence

Intention – With Partners, better understand the causes to prevent and reduce instances of Anti-Social Behaviour, Disorder and Violence to enhance community safety across the Highland Area.

Objective – Work with Partners to share information, support Education, Prevention, Diversionary and Enforcement Measures linked to harmful alcohol consumption; maintain robust procedures around licensed premises; support victims of violent crime by working with partners to improve service provision and prevent repeat victimisation.

Assault to varying degrees have featured in June. Offences have been committed within both domestic and public settings in Invergordon, Milton and Alness. In many cases the perpetrators have been arrested and charged, or where appropriate issued with a Recorded Police Warning. There have been two assaults recorded against Police Officers.

Ten offences of Vandalism have been recorded, mostly to residential addresses. Damage has consisted in many cases of smashed windows. Several offences have been detected.

**Acquisitive Crime**

Intention – With Partners and Communities, prevent instances of acquisitive crime across the Highland area.

Objective – With Partners, share information, support education, prevention, diversionary and enforcement activity linked to acquisitive crime; develop work with targets – recidivist offenders to reduce reoffending linked to acquisitive crime e.g. Persistent Offenders programme; enhance the use of all media platforms to raise awareness of local and national preventative initiatives.

Local convenience stores, supermarkets and pharmacies have been targeted by shoplifters on five occasions during June. Enquiries continue to identify and trace those responsible.

A break-in to a residential address in Invergordon, whereby property was stolen is currently being investigated.

There have been three offences of fraud committed online and by debit card to purchase items.

**Protecting Vulnerable People**

Intention – Protect people at risk of harm.

Objective – With Partners and as corporate parents we will deliver the Highland CHAMPS (Highland Champion Board) strategy; with Partners we will focus on safeguarding communities; with Partners we will address emerging issues through Prevention and Intervention.

There is nothing specific to report for the reporting period under this section however, protecting vulnerable people remains a priority for local officers. Calls regarding concern for person and mental health related incidents are attended frequently. These calls can have quite an impact on local resources however there is currently a review ongoing at executive level to ensure Police Scotland are providing the most appropriate response to these types of incidents. ### Serious and Organised Crime

Intention – With Partners, reduce the threat, risk and harm caused by Serious Organised Crime.

Objective – With Partners work to safeguard the Highland area by taking all opportunities to prevent crime and make the Highland area a hostile environment for Serious & Organised Crime Groups; to improve outcomes for individuals and communities and reduce offending through prevention, early intervention and diversion; in support of our Partners in the Local Authority and NHS via the Highland Alcohol and Drug Partnership Strategy we will direct those who are substance dependant towards recovery through prevention, treatment and support services; with Partners work to reduce the instances of substance misuse in our communities.

After a warrant under the Misuse of Drugs Act was executed at an address in Invergordon, a quantity of what is suspected to be controlled drugs were recovered. The occupant of the address was arrested. The investigation is ongoing.

Police Scotland continues to tackle substance abuse within our communities by using tactics such as proactive searches of individuals and pre-planned, intelligence-led enforcement.

Officers continue to record and act upon all intelligence submitted to Police Scotland regarding serious and organised crime and encourage public to report suspicious activity via contact us form on the website or via 101.

### Counter Terrorism

Intention – Support the delivery of the CONTEST strategy to reduce the threat posed by terrorism and domestic extremism.

Objective – Strengthen PREVENT work with Partners and institutions; with Partners, support individuals who are vulnerable to terrorism and violent extremism; strengthen PREVENT work in relation to the internet and Social Media; Effective Multi-agency planning in respect of Counter Terrorism is taking place; Develop our ability to response effectively to any terrorist attack (with a specific focus on emerging high-risk threats, and specialist capabilities).

ACT Early is a program delivered to schools across the Highland area. The ACT Early session is a vehicle for debate around the sensitive issue of violent extremism within communities. As such it is an enabler for community participants to air grievances, debate matters of interest to them and work through a group problem solving experience.
